Qualifying Requirements for Insurance Companies – Terms & Conditions

1. Eligibility & Registration

The bidder must be a registered Indian Insurance Company under the Insurance Act, 1938 and duly registered and licensed by the Insurance Regulatory and Development Authority of India (IRDAI) to carry out general insurance business in India.

2. Declaration regarding Blacklisting

The Tenderer shall submit a self-declaration on its official letterhead along with the Technical Bid stating that the company has not been blacklisted, de-listed, or placed under holiday by any Indian Institutional Agency, Government Department, or Public Sector Undertaking during the last three (3) years.

In case the bidder has been blacklisted/de-listed, full details of the same shall be furnished. The bidder shall also certify that no restraint order has been passed against it by any competent court of law.

3. Submission of Supporting Documents

The offer must be accompanied by proper documentary evidence substantiating the fulfilment of the above qualifying requirements.

4. Right to Accept or Reject

The BCC Bank reserves the absolute right to accept or reject any offer, either in full or in part, without assigning any reason whatsoever.

5. Finality of Decision

The decision of the Bank in this regard shall be final and binding on all bidders.
